



Compositions of Dividend Payments 派息組成份

重要事項：

1. 易方達精選策略系列—易方達（香港）精選債券基金（「子基金」）須受限於一般市況波動及子基金資產的其他固有因素。因此，閣下須承擔無法收回投資於子基金的本金或可能損失大部分或全部投資的風險。

3. 子基金可在守則准許的範圍內投資於衍生工具作對沖或投資目的，而在不利情況下，其運用金融衍生工具可能變得無效及/或致使子基金蒙受重大損失。使用金融衍生工具附帶的風險包括波動性風險、信用風險、流動性風險、管理風險、估值風險、交易對手風險及場外交易風險。金融衍生工具的杠杆元素/成分可導致損失遠遠大於本基金投資于金融衍生工具的金額。投資金融衍生工具可致使本基金存在蒙受重大損失的高風險。
4. 對沖單位類別的分派金額及資產淨值可能受到有關對沖單位類別的類別貨幣與子基金的基礎貨幣的利率差異之不利影響，導致從資本中支付的分派金額有所增加，以及因此相對其他非對沖單位類別的資本流失更大。
5. 除非仲介人於銷售基金時已向閣下解釋經考慮閣下的財務情況、投資經驗及目標後，此基金是適合閣下的，閣下不應投資子基金。

Important Note：

1. Investment in the E Fund Selection Investment Series – E Fund (HK) Select Bond Fund (the “Sub-Fund”) is subject to normal market fluctuations and other risks inherent in the Sub-Fund’s assets. Accordingly, there is a risk that you may not recoup the original amount invested in the Sub-Fund or may lose a substantial part or all of your investment.
2. 4. Distributions of the Sub-Fund may be paid out of the capital of the Sub-Fund. Investors should note that payment of distributions out of capital amounts to a return or withdrawal of part of an investor’s original investment or from any capital gains attributable to that original investment and such distributions will result in an immediate reduction of the net asset value of the relevant units. The distribution amount and net asset value of the hedged unit class may be adversely affected by differences in the interest rates of the class currency of the hedged unit class and the Sub-Fund’s base currency, resulting in an increase in the amount of distribution that is paid out of capital and hence a greater erosion of capital than other non-hedged unit classes.

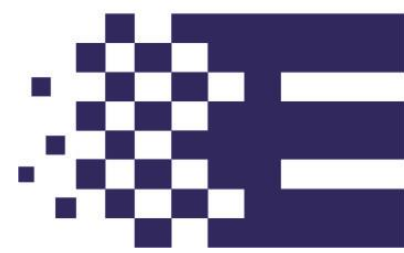

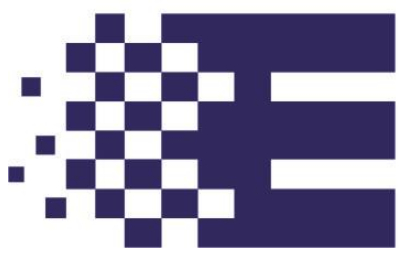

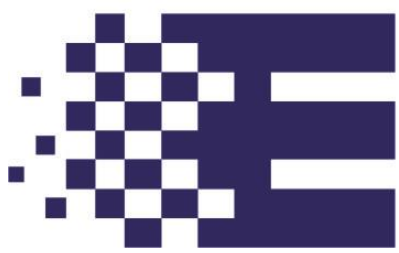
